Terms and Conditions

The following expression shall have the following meaning in this agreement. "HostLink" means HostLink (HK) Limited

This agreement represents the complete agreement and understanding between HostLink and the account holder (hereinafter called Customer) and supersedes any other written or oral agreement. Upon notice published on-line via HostLink services, HostLink may modify these terms and conditions, amplify them, and/or modify the prices, as well as discontinue or change services offered.

If you do not agree to these terms and conditions, please notify our Customer Services Department at 2771 7387 so we can initiate a closure of your account. USE OF YOUR ACCOUNT shall constitute your approval.

1. Services provided to the Customer by HostLink may only be used for lawful purposes. Transmission or publication of any information, data or material in violation of any Hong Kong regulation or law is prohibited. This includes, but is not limited to, material protected by copyright, trade secret or any other statute, threatening material or obscene material. HostLink reserves the right to remove any and all materials which infringe on copyright work. Such materials will be removed at any time upon receiving a complaint and or notice of copyright infringement.
2. HostLink reserves the right to cancel service for any reason without prior notice. In case of cancellation, unused fees may be returned to the subscriber on a pro-rata basis. Fees for setup and the first month's service are not refundable.
3. HostLink makes no warranties of any kind, whether expressed or implied, for the service it is providing. HostLink also disclaims any warranty of merchantability or fitness for a particular purpose. HostLink will not be responsible for damages the customer suffers. This includes loss of data resulting from delays, non-deliveries, misdeliveries, or service interruptions caused by its own negligence, subscriber's errors or omissions, or due to the fault of third parties.
4. Customer agrees to defend, hold harmless and expeditiously indemnify HostLink from any liability, claim, loss, damage or expense arising out of the indemnifying party's breach or violation of any covenant contained in this Policy and resulting from the Customer's use of the service.
5. HostLink accounts cannot be transferred or used by anyone other than the subscriber. Customers may not sell, lease, rent or assign the connection or parts of the connection to any party not named in this Policy. Customer may allow ftp access to its server and host web sites for its customers without violating this Policy.
6. Setup fees are not refundable.
7. Additionally, CUSTOMER agrees not to utilize the HostLink service, equipment or email address in connection with the transmission of the same or substantially similar unsolicited message to 100 or more recipients or ten or more newsgroups in a single day.
8. Customer agrees not to transmit, promote, or otherwise make available any software, product or service that is either illegal or designed to violate this Agreement. Such software, products or services include, but are not limited to, programs designed to send unsolicited advertisements and services which send unsolicited advertisements.
9. Customer shall ensure that its use of HostLink's network services shall not disrupt HostLink, its associated networks or equipment forming part of the systems. In instances in which an excessive amount of system resources are utilized by a subscriber, HostLink reserves the right to place CPU process limits on the Customer's account to prevent disruption of service to other customers. Customers shall not transmit any communication where the meaning of the message, or its transmission or distribution, would violate any applicable law or regulation or would likely be offensive to the recipient thereof. No message may be mass distributed, "broadcast," or otherwise sent on an intrusive basis to any HostLink user or to any directly or indirectly attached network. Use of HostLink's connection in a manner that is disruptive, damaging, unlawful, offensive, or intrusive as determined by HostLink shall be considered a breach of this Policy and may result in cancellation of service. This prohibition extends to sending of unsolicited mass mailings from another service which in any way implicates the use of HostLink's service, HostLink's equipment or any site hosted on any HostLink network.
10. Customer warrants that any material submitted for publication on HostLink does not violate or infringe any copyright, trademark, patent, statutory common law or proprietary interest of others or contain anything obscene or libelous. HostLink reserves the right to remove any and all materials which infringe on copyright work. Such materials will be removed at any time upon receiving a complaint and or notice of copyright infringement.
11. If HostLink becomes aware of material that could be infringing on a third party's copyright, it will initiate an investigation. To conduct an investigation of copyright infringement, the Complainant must submit at least two items. First, Complainant must submit a claim in writing with the applicable copyright or trademark registration number and a copy of the underlying copyrighted work along with the Customer's materials. Second, Complainant must offer a good faith certification signed under penalty of perjury. This certification must state that the work is the property of the Complainant, that the work has been copied and that use of the work is not defensible. With this information in-hand, HostLink, at its discretion, may, at any time deny access to the challenged material of Customer.
12. Your domain name should be assigned within 7-10 working days and is not guaranteed until confirmation is received.
13. Customer may terminate the subscription of service by a 30 day prior Written Notice serving on HostLink. Customer may not terminate the service without proper prior Written Notice on a duration shorter than specified herein. The Customer shall be responsible for all fees before a proper termination of the service in accordance with this Agreement.
14. On occasion, HostLink may have a need to communicate with its customers through e-mail issues related to billing, as well as changes, additions and modifications to the network. It is the responsibility of the customer to check e-mail sent to the primary login e-mail address on the account.
15. It is the responsibility of the customer to contact HostLink of any changes to their account, such as phone number, address, etc. Customers will be required to provide verification for security purposes authorizing them to make any changes to that account. <<End>>
